Courts: The Court of First Instance and the Court of Appeal established pursuant to

pursuant to the DIFC Laws.

Arbitral Award: Any arbitration award recognised by the DIFC Laws or any foreign

arbitration awards that satisfies the requirements of the DIFC Laws.

Rules of the Courts: The rules regulating litigation procedure before the Courts.

Article 3

The Dubai International Financial Centre Courts

- (1) The Courts of the Centre are hereby established and shall carry out their functions in an independent manner, in accordance with the provisions of this Law and the provisions of the other Centre's Laws and Regulations. The Courts shall be of two ranks; The Court of First Instance and the Court of Appeal.
- (2) The Courts shall be situated in the Centre, and may, when necessary, hold hearings anywhere else in the Emirate.
- (3) The Court of First Instance shall be composed of a single judge and the Court of Appeal of a presiding judge and two judges. The Court of First Instance and the Court of Appeal shall have one or more circuits. The Chief Justice, or the most senior of the judges when necessary, shall preside over the Court of Appeal.
- (4) The judges, including the Chief Justice, shall be appointed by a decree issued by the Ruler.
- (5) Judgements of the Courts shall be issued in the name of the Ruler.
- (6) The judgement of the Court of Appeal shall be unanimous or rendered by the majority and the minority shall note a dissenting judgement next to the judgment of the majority.

Article 4 Duties and Powers of the Chief Justice of the Courts

- (1) The Courts shall have a Chief Justice and a Deputy Chief Justice appointed pursuant to a decree issued by the Ruler.

- (2) In addition to the powers and duties granted to the Chief Justice of the Courts by the DIFC Laws, the Chief Justice of the Courts shall undertake general supervision of the Courts, and for this purpose he shall have the following duties and powers:

I. Administrative Duties and Powers:

(a) To set up the different Courts' circuits and divisions;

- (b) To determine the infrastructures, buildings, administrative services and any other services necessary to achieve the objectives of the Courts, and to submit recommendations in this respect to the President to take the necessary action as he deems appropriate;

- (c) To enter into contracts, agreements and memoranda of understanding with third parties within or outside of the Emirate in order to achieve the objectives of the Courts, and to acquire, own and dispose of movable property pursuant to DIFC Laws.

II. Technical Duties and Powers:

- (a) To propose and submit to the President the draft DIFC Laws concerning any matter falling within the Courts' jurisdiction; [16/2011 wef 31/10/2011]
- (b) To approve and issue the Rules of the Courts and the DIFC Regulations falling within the Courts' jurisdiction; [16/2011 wef 31/10/2011]
- (c) To carry out public consultation on any draft DIFC Laws or draft DIFC Regulations falling within the Courts' jurisdiction. [16/2011 wef 31/10/2011]
- (3) The Chief Justice of the Courts may delegate any of his administrative powers to his deputy, to any of the judges of the Courts or to the Registrar of the Courts.

(4) In addition to the duties and powers assigned to him by the Chief Justice of the Courts, the Deputy Chief Justice of the Courts shall undertake all the duties and powers of the Chief Justice of the Courts in the event of his absence.

Article 5

Jurisdiction

(A) The Court of First Instance:

(1) The Court of First Instance shall have exclusive jurisdiction to hear and determine:

- (a) Civil or commercial claims and actions to which the DIFC or any DIFC Body, DIFC Establishment or Licensed DIFC Establishment is a party; [16/2011 wef 31/10/2011]
- (b) Civil or commercial claims and actions arising out of or relating to a contract or promised contract, whether partly or wholly concluded, finalised or performed within DIFC or will be performed or is supposed to be performed within DIFC pursuant to express or implied terms stipulated in the contract;

- (c) Civil or commercial claims and actions arising out of or relating to any incident or transaction which has been wholly or partly performed within DIFC and is related to DIFC activities;

- (d) Appeals against decisions or procedures made by the DIFC Bodies where DIFC Laws and DIFC Regulations permit such appeals; [16/2011 wef 31/10/2011]

- (e) Any claim or action over which the Courts have jurisdiction in accordance with DIFC Laws and DIFC Regulations. [16/2011 wef 31/10/2011]
- (2) The Court of First Instance may hear and determine any civil or commercial claims or actions where the parties agree in writing to file such claim or action with it whether before or after the dispute arises, provided that such agreement is made pursuant to specific, clear and express provisions.

- (3) The Court of First Instance may hear and determine any civil or commercial claims or actions falling within its jurisdiction if the parties agree in writing to submit to the jurisdiction of another court over the claim or action but such court dismisses such claim or action for lack of jurisdiction.

- (4) Notwithstanding Clause (2) of Paragraph (A) of this Article, the Court of First Instance may not hear or determine any civil or commercial claim or action in respect of which a final judgment is rendered by another court.

(B) The Court of Appeal:

(1) The Court of Appeal shall have exclusive jurisdiction to hear and determine:

(a) appeals filed against judgments and decisions made by the Court of First Instance;

(b) request of interpretation by the Chief Justice of the Courts of any article of the DIFC Laws and DIFC Regulations upon an application submitted to him from any DIFC Body, DIFC Establishment or Licensed DIFC Establishment; such interpretation shall have the same authority as the interpreted legislation.

(2) Judgments rendered by the Court of Appeal shall be final and conclusive, and shall not be subject to appeal by any means of appeal.

(C) The procedure prescribed in the Rules of the Courts shall apply to all civil and commercial claims and actions heard by DIFC Courts.

(D) DIFC Execution Judge

The Chief Justice of the Courts shall assign one or more of the Courts' judges as execution judge(s).

Article 6

Governing Law

The Courts shall apply the Centre's Laws and Regulations, except where parties to the dispute have explicitly agreed that another law shall govern such dispute, provided that such law does not conflict with the public policy and public morals.

Article 7

Execution

(1) The execution judge assigned pursuant to Paragraph (D) of Article (5) of this Law shall have jurisdiction over execution of the judgments, decisions and orders rendered by the Courts and the Arbitral Awards

ratified by the Courts if the subject matter of execution is situated within DIFC, and such execution shall be in accordance with the Rules of the Courts.

Where the subject matter of execution is situated outside the DIFC, the judgments, decisions and orders rendered by the Courts and the Arbitral Awards ratified by the Courts shall be executed by the competent entity having jurisdiction outside DIFC in accordance with the procedure and rules adopted by such entities in this regard, as well as with any agreements or memoranda of understanding between the Courts and these entities. Such execution shall be subject to the following conditions:

(a) The judgment, decision, order or ratified Arbitral Award to be executed is final and executory;

(b) The judgment, decision, order or ratified Arbitral Award is translated into the official language of the entity through which execution is carried out;

(c) The Courts affix the executory formula on the judgment, decision, order or ratified Arbitral Award.

(3) In addition to Paragraphs (a), (b) and (c) of Clause (2) of this Article, when executing the judgments, decisions and orders issued by the Courts or Arbitral Awards ratified by the Courts through Dubai Courts, the following must be observed:

(a) the Courts shall issue an execution letter to the Chief Justice of the Court of First Instance of Dubai Courts stating the procedure to be carried out;

(b) the person requesting execution shall submit to the execution judge of Dubai Courts an application accompanied by a copy of the judgment, decision or order, legal translation of the same, and the execution letter;

(c) the execution judge of Dubai Courts shall apply the execution procedure and rules stipulated in the aforementioned Federal Civil Procedure Code, including any objections to the execution; the execution judge may not reconsider the merits of the judgment, decision or order;

- (d) Dubai Courts shall collect the execution fees for each execution request submitted to them in accordance with the aforementioned Dubai Courts Fees Law. [16/2011 wef 31/10/2011]
- Where the subject matter of execution is situated in DIFC, the judgments, decisions and orders rendered by Dubai Courts or Arbitral Awards ratified by Dubai Courts shall be executed by the execution judge of the Courts subject to the following conditions:

 - (a) The judgment, decision or order to be executed is final and executory;

(b) The judgment, decision or order is translated into English by the person requesting execution;

(c) Dubai Courts affix the executory formula on the judgment, decision or order.

(5) In addition to Paragraphs (a), (b) and (c) of Clause (4) of this Article, when executing, through the Courts, the judgments, decisions or orders issued by Dubai Courts and Arbitral Awards ratified by Dubai Courts, the following must be observed:

- (a) the Dubai Courts shall issue an execution letter to the Chief Justice of the Courts stating the procedure to be carried out; [16/2011 wef 31/10/2011]
- (b) the person requesting execution shall submit to the execution judge of the Courts an application accompanied by a copy of the judgment, decision or order, legal translation of the same, and the execution letter; [16/2011 wef 31/10/2011]
- the execution judge of the Courts shall apply the execution procedure and rules stipulated in the Rules of the Courts, including any objections to execution. The execution judge may not reconsider the merits of the judgment, decision or order;

- (d) the Courts shall collect the execution fees for each execution request submitted to them in accordance with their applicable fees law. [16/2011 wef 31/10/2011]
- The judgments, decisions, orders and ratified Arbitral Awards rendered outside DIFC by any court other than Dubai Courts shall be executed within DIFC in accordance with the procedure prescribed in the Rules of the Courts.

Article 8

Liability of Judges

Judges at the Courts shall not be held liable for anything done or omitted to be done in the performance of their functions unless proven that the same has been in bad faith.

Article 9

The management of the Courts affairs, the prosecution proceedings and the enforcement shall be regulated by virtue of a special law.

Article 10

Any text in any other law to the extent that it contradicts this Law shall be repealed.

Article 11

This Law shall be published in the Official Gazette and shall become effective from the date of publication.
