### 1. Welcome by Chairman:

Registrar Mark Beer chaired the meeting and welcomed all attendees

# 2. Approval of the last minutes of meeting

The minutes of the Courts' Users' Committee meeting held on 11 December 2014 were approved

# 3. Business Visit Visas for Visiting Counsel:

Reem Al Shihhe, Chief Operating Officer at the DIFC Courts gave an update on the new Business Visit Visa services that DIFC Courts will be offering as of 1 February 2015 for lawyers based outside UAE. She updated the members with the types of visas, duration, eligibility and the fees for processing the business visas through the DIFC Courts.

Some members enquired if this service was a requirement for all visiting counsel to which Reem Al Shihhe replied that it is an optional service provided by the DIFC Courts and that we received the first application in the 1<sup>st</sup> week of February 2015. Lawyers are encouraged to make use of this service.

As part of the application process an applicant is required to demonstrate that he or she is registered with the DIFC Courts. Members suggested that the DIFC Courts should be able to check internally if a practitioner is registered instead of requesting the applicant to send a proof of their registration to the Courts. This was acknowledged by Reem Al Shihhe and the practitioner's registration process will be changed.

Reem Al Shihhe clarified that lawyers from Category A who apply for a 30 or 90 days business visit visa can exit and on return use the same business visit visa which is not the same for lawyers from Category B, who have to obtain a new business visit visa on re-entry into the country.

For lawyers appearing at DWT hearings this will be an optional service as well although the lawyers are not required to be registered under the Part II of the DIFC Courts' Register of Legal Practitioners to appear at DWT hearings.

All information regarding obtaining a business visit visa is now available on the DIFC Courts' website and the contact person will be Shila Katira, HR and Business Excellence Specialist.

# 4. **IT strategy/ interCOMM v4 upgrade:**

Trevor Pegley from Visionhall provided the meeting with an overview of the forthcoming eRegistry upgrade which is due end of March 2015. The new system builds on the success of the old one, while adding many new features to make it easier for court users to register and conduct business with the court online. A period of beta testing is due to start shortly involving the court user community. He also provided the members with an overview of how the new system would look and explained some of the features that the new upgraded version would have while still retaining the same eforms.

Some members remarked that the "search" functionality on the new courts website was not user friendly. This was acknowledged by the Courts and Visionhall has now deployed a new enhanced search engine.

- The average value per CFI and ARB claim stands at USD11.43m (AED42m) a 25% increase from 2013.

#### 12. **2015 Work Plan:**

Registrar Mark Beer updated the members of the Courts' Users' Committee about the 2015 Work Plan which was presented by Chief Justice of the DIFC Courts Michael Hwang on 19 January 2015. He highlighted that DIFC Courts will have greater engagement with lawyers and business people and how the courts will continue to maintain and develop their strong links with other courts.

H.E. Justice Omar Al Muhairi remains a key liaison between DIFC Courts and Dubai Courts.

H.E. Justice Ali Al Madhani and Judicial Officer Nassir Al Nasser will continue to build links with the Saudi judiciary.

Judicial Officer Maha Al Mehairi, will build links with Abu Dhabi Judicial Department and UAE Ministry of Justice.

DIFC Courts will support Judicial Officers Maha Al Mehairi and Nassir Al Nasser to further advance their judicial careers.

Registrar Mark Beer spoke about the development of the Dispute Resolution Authority, which will be headed by Chief Justice of the DIFC Courts Michael Hwang.

The proposed revised fee structure was also shared with the members.

Members were informed that Assistant Registrar, Natasha Bakirci is working on a new draft order which raises the Small Claims Tribunal's jurisdiction for all claims to 500,000 AED – with a limit of 1 million AED for non-employment claims and no cap for employment claims where parties agree.

Some members suggested that legal representation should be allowed at Small Claims Tribunals, especially in employment cases as a company can use inhouse counsel while an individual cannot use a lawyer.

### 13. **DIFC Courts' training:**

Assistant Registrar Natasha Bakirci gave updates on the DIFC Courts training progress following introduction of Legal Affairs Department CPD scheme.

Certain CUC members expressed the view that some practitioners might benefit from further training on the Rules of the DIFC Courts (RDC).

Members wanted to know if there are any plans to introduce CPD training or a point system for DIFC registered practitioners to which Assistant Registrar Natasha Bakirci clarified that any lawyer practising in Dubai has to do 16 hours as CPD a year and if they are practising in the DIFC two of those hours have to be DIFC related. This will come into force from March 2015.

Others questioned whether CPD earned in their home jurisdictions would be recognised by the Legal Affairs Department.

### 14. **DIFC Wills and Probate Registry:**

Mihaela Moldoveanu, Project Manager, DIFC Courts provided the below updates to members about the DIFC Wills and Probate Registry:

It is hoped to launch the DIFC Wills and Probate Registry within the next two months.

DIFC will be the first jurisdiction in the MENA region where one can register a will under internationally recognised common law.

The Registry will be an office where eligible people can register their English language wills for their Dubai estates, allowing the ensuing probate process to take place in the DIFC Courts

A set of new rules guiding the functioning of this service have been drafted on the basis of Common Law principles from the Estates Act and Probate Rules of the UK and from other leading jurisdictions, such as Singapore and Malaysia.

When members inquired if an estate from other emirates will be covered, Mihaela Moldoveanu informed the members that only the Dubai estate will be covered at this stage and the estate in the other emirates will not be covered.

#### 15. Nomination of new members to the Courts' Users' Committee:

As we had an overwhelming response to our request for nominations from law firms to become a member of the Committee, a ballot was taken to select the two new members. Adrian Chadwick from Hadef & Partners and Peter Gray from Gibson Dunn stepped down and were replaced by Esam Omar Sharaby from Hussain Lootah Law and Associates (UAE firm) and Graham Lovett from Clifford Chance (International firm) respectfully.
